Earthdog Practice Friday and Saturday Afternoon:

Conducted within the policies and constraints of the AKC, supervised earthdog practice will be offered Friday and Saturday afternoon. For more information or to sign up for the practices, go to our Facebook Page (Atlanta Terrier Club) and look in the files section. The practice entry form will also be available on the club website at <https://atlantaterrierclub.org>.

Practice Entry Forms and run fees (\$10/run) should be returned with your Test Entry Form.

Classes Offered: IQ: Open to all eligible breeds, non-regular class with no credit toward titles. NE: Open to all eligible breeds who have not previously earned an Earthdog title. JE: Open to all eligible breeds. SE: Open only to dogs that have acquired a JE title. ME: Open only to dogs that have acquired a SE title. A dog may be entered in both IQ (Non-regular) and JE (Regular). Dogs may enter multiple classes in each event provided the dog is eligible for the classes. Any dog may enter a Junior Class test, but no further JE certificates will be issued.

Pre-entry Fees: IQ (Non-Regular) \$22.00; NE, JE, SE & ME \$25.00. All entries must be accompanied by entry fees and the entry form to be valid.

“Day-of” Entries accepted for IQ, NE, JE, and SE. “Day Of” entries close 30 minutes prior to the start of each event. Day-of Test Entry Fees (IQ, NE, JE, and SE only): IQ - \$25.00, NE, JE & SE - \$30.00.

Move-Ups accepted until 8:00 AM for Saturday morning event; 12:00 Noon for Saturday afternoon event; and 8:00 AM for Sunday morning event.

Refunds: There will be no refunds for entries withdrawn after the closing date or in the event that a dog and/or handler are dismissed from competition regardless of the reason for such dismissal, except for bitches in heat (see paragraph below). No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.

Bitches in season may not be entered. Entry fees will be refunded (except for \$3.50 AKC Fee) for bitches in season with Veterinary certificate or presentation of the bitch to the committee. A request must be made before 8:00 AM on the day of entered test.

Dogs Sick/Injured. ATC will refund total entry fees less \$10.00 per day for dogs that become sick/injured after the closing date. A veterinarian's certificate must be presented to the Trial Secretary prior to the start of judging on Saturday.

Entries may be completed in any of the following 2 methods:

Awards:

Double flat ribbons will be awarded for IQ qualifiers.

Rosettes will be awarded for qualifying runs of NE, JE, SE and ME and for new titles.

Each judge will present a special memento as a "Judge's Choice Award" after the third trial based on all performances.

NE: ½ hour after morning judging is complete or 2:45 PM, whichever is earlier. Check in by 2:15 PM.

JE: ½ hour after morning judging is complete or 3:45 PM, whichever is earlier. Check-in by 3:15 PM.

SE: ½ hour after morning judging is complete or 2:45 PM, whichever is earlier. Check-in by 1:30 PM.

ME: 1:30 PM. Check-in by 1:00 PM (Brace drawing at 1:15 PM).

Sunday Morning, November 24, 2024

IQ: 9:00 AM. Check-in by 8:30 AM.

NE: 10:00 AM. Check-in by 9:30 AM.

JE: 11:00 AM. Check-in by 10:30 AM.

SE: 10:00 AM. Check-in by 9:30 AM.

ME: 8:45 AM. Check-in by 8:15 AM (Brace drawing at 8:30 AM).

Orientation for each class will be 15 minutes prior to starting time. Please be mindful of the time, as the judges will stay on schedule.

Check-In and Running Order:

Entrants are requested to check in prior to the start of their class. Entrants not appearing when called will be moved to the end of the order. Dogs will run in the order entries received with consideration given to multiple dogs with the same handler, dogs entered in multiple classes, volunteers and workers.

Dogs entered by the closing date that qualify to enter a test other than the one on their entry form may have their entry changed by contacting the Test Secretary by 8:00 AM on the test day.

***Eligible Breeds:** Dachshunds and terrier breeds: American Hairless Terrier, Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Glen of Imaal, Jagdterrier, Japanese Terrier, Smooth Fox, Wire Fox, Parson Russell, Lakeland, Manchester, Miniature Bull, Miniature Pinschers, Miniature Schnauzer, Norfolk, Norwich, Rat, Russell, Sealyham, Scottish, Silky, Skye, Welsh, Teddy Roosevelt Terrier, West Highland White and Yorkshire. Dogs must be 6 months of age and registered with the AKC or have a PAL/ILP granted by the AKC. A dog of eligible breed with an acceptable foreign registration number is eligible to participate subject to Chapter 11, Sec. 1 of the Dog Show Rules.

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are able to perform safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The ATC will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. ATC reserves the right to decline entries for

cause and may remove any dog on account of aggression. No one shall have any recourse or claim against ATC or any official thereof.

All dogs must be confined or on leash except when judged. No Flexi Leads or pinch collars allowed on site.
